1. Complete the information requested below and submit a non-refundable application fee of \$50 (payable to "Mills College"), along with this form, to the M Center, Mills College, 5000 MacArthur Blvd, Oakland, CA 94613 (510.430.2000, records@mills.edu). **Applications received without payment will be returned.**
2. Any previous outstanding financial obligation to the College must be resolved before this application will be considered. Contact Collections (510.430.3180) or smaxie@mills.edu.
3. If you intend to live on campus please contact Housing Management and Dining Services (510.430.2127 or housing@mills.edu) for information about obtaining on-campus housing.
4. If you are an international student on a student visa, please contact the Division of Student Life (510.430.2130, student_life@mills.edu).
5. Students are readmitted under the catalog in effect at the time of their original admission.
6. The address listed on this form will be used to update your Mills permanent address on record.

Instructions for Undergraduate Students

1. Applications for Readmission will be reviewed by the Academic Standing Committee which meets each Monday when school is in session. Students are notified of the Committee's decision via the email address entered on the form. Undergraduate students who have been away from Mills for more than 5 years must reapply through the Office of Undergraduate Admission.

Instructions for Graduate Students

1. Applications for Readmission are submitted to Graduate Admissions, who notifies the students of its decision via U.S. mail. Graduate students who have been away from Mills for more than two years must re-apply directly to the Office of Graduate Admission.

Instructions for Disqualified Students

1. Disqualified students must complete at least one full-time semester of transferrable course work from a regionally accredited college or university before they will be considered for readmission.
2. Submit the official, sealed transcript with your application.
